Personal data that we process

NowPlaying processes your personal data because you use our services and / or because you provide them yourself. Below you will find an overview of the personal data that we process:

- First and last name
- E-mail address
- IP address
- Other personal data that you actively provide, for example by creating a profile on this website, in correspondence and by telephone
- Information about your activities on our website
- Information about your surfing behavior across various websites (for example, because this company is part of an advertising network)
- Internet browser and device type

Special and / or sensitive personal data that we process

Our website and / or service does not intend data collect about website visitors under the age of 16. Unless they have permission from their parents or guardian. However, we cannot check whether a visitor is older than 16. We therefore advise parents to be involved in the online activities of their children, in order to prevent data about children from being collected without parental consent. If you are convinced that we have collected personal information about a minor without this permission, please contact us via nowplaying@stephantollenaar.nl and we will delete this information.

For what purpose and on what basis we process personal data

NowPlaying processes your personal data for the following purposes:

- To be able to call or e-mail you if necessary to carry out our services

- To offer you the option of an account make
- nowplaying analyze your behavior on the website in order to improve the website and the range of products and services align to your preferences.

Automated decision-making decisions

NowPlaying does not make based on automated processing on matters that can have (significant) consequences for people. These are decisions taken by computer programs or systems, without involving a person (for example, an employee of NowPlaying).

How long we keep personal data

NowPlaying does not store your personal data longer than is strictly necessary to achieve the purposes for which your data is collected. However, most personal and account information will be retained until NowPlaying decides to discontinue its services.

Sharing personal data with third parties

NowPlaying does not sell your data to third parties and only provides it if this is necessary for the execution of our agreement with you or to comply with a legal obligation. We conclude a processor agreement with companies that process your data on our behalf to ensure the same level of security and confidentiality of your data. NowPlaying remains responsible for these processing operations.

Cookies, or comparable techniques, that we use

NowPlaying uses functional, analytical and tracking cookies. A cookie is a small text file that is stored in the browser of your computer, tablet or smartphone when you first visit this website. NowPlaying uses cookies with a purely technical functionality. These ensure that the website works properly and that, for example, your preferred settings are remembered. These cookies are also used to make the website work properly and to optimize it. In addition, we place cookies that keep track of your surfing behavior so that we can offer customized content and advertisements. On your first visit to our website, we have already informed you about these cookies and asked permission to place them. You can opt out of cookies by setting your internet browser so that it no longer stores cookies. In addition, you can also delete all information previously stored via the settings of your browser. View, modify or delete data

You have the right to view, correct or delete your personal data. You also have the right to withdraw your consent to the data processing or to object to the processing of your personal data by NowPlaying and you have the right to data portability. This means that you can submit a request to us to send the personal data we hold about you in a computer file to you or another organization mentioned by you. You can send a request for access, correction, deletion, data transfer of your personal data or request for cancellation of your consent or objection to the processing of your personal data to nowplaying@stephantollenaar.nl. To ensure that the request for access has been made by you, we ask you to send a copy of your ID with the request. Make your passport photo, MRZ (machine readable zone, the strip with numbers at the bottom of the passport), passport number and citizen service number (BSN) black in this copy. This is to protect your privacy. We will respond to your request as soon as possible, but within four weeks. NowPlaying would also like to point out that you have the option to file a complaint with the national supervisory authority, the Dutch Data Protection Authority.
